I also agree that I am responsible for any damages that I willfully or unintentionally or negligently inflict upon the facilities and property, either real or personal, of the Daytona Beach Shores Department of Public Safety's.

It is understood and agreed by me that the privilege granted me to use the facilities of the Daytona Beach Shores Department of Public Safety will only be exercised by me after I make

specific arrangements with the Director or his designated representative. It is further understood and agreed by me that this privilege may be revoked at any time by the Director or his designated representative, with or without cause and without notice or hearing.

I fully understand the consequences of the terms of this agreement, including the general release.
